A BINGO!!- KATHRYN HAS TAKEN THE LEAD ON BINGO. We have been approved to run Bingo slots at Community Spirit Bingo, located at 900 Division St, effective APRIL 1st. This
opportunity may potentially bring in $\$ 20,000$ annually for the school, which may be spent on ALL students ie. Pay for entire field trips. We have been selected because a previous team's commitment has not be fulfilled, and we have been put into their slot. Community Spirit Bingo, has a 3 strike system, and once you have had those strikes, you may not apply again. Due to how our slot became available we do not have a say in the days/times we are given, and we must comply with the schedule provided to us, for this year. All bingo's must have 2 volunteers on each shift, which may be broke down into $2 \mathrm{hr}-4 \mathrm{hr}$ slots. All volunteers must wear black pants, collared shirt which has organization logo or collared shirt with a organization logo on a vest, and closed toe shoes. Volunteers must be trained prior to working any shift, and will not do any money exchanges. Simply calling back number of card to caller and cleaning tables. Kathryn will make a Google sheet to sent out for volunteers to sing up, but everyone will need to download the app.
