Annual Report 2019-2020 School Year

Dear Parents and School Community:

Welcome back! We hope you are staying safe and enjoyed your summer. The Glenburnie Public School Council had a very rewarding 2019-2020. The school council held 7 meetings on September 9; October 7; November 4; December 2; January 13; February 3; March 2; and worked on various projects during the year including organizing school community events, supporting school organized activities and planning our annual Fun Fair/Silent Auction. These meetings were open to the public to encourage input from parents and other members of the school community.

The purpose of the school council is to help improve student achievement and to enhance the accountability of the education system to parents. School councils are advisory organizations. A school council's primary means of achieving its purpose is by making recommendations to the principal of the school and the school board. Boards and principals are responsible for considering the recommendations made by each school council and for advising the council of the actions taken in response to the recommendations. However, during the 2019-2020 school year, Glenburnie's School Council did not face any situations that required the need to make any recommendations to the principal or the school board. In the event that any future recommendations are brought forth we will strive to work together with the principal and staff. All input from all parties will be listened to, considered and decisions will be made together.
